ORDER

Whereas, an order has been issued by the Chief Secretary to the Government of West Bengal vide Memo No. 177-CS/2020 dated 18/5/2020 which prescribes for categorization of zoning in order to contain the spread of COVID 19;

And whereas, a few COVID 19 positive cases have been reported from certain areas of the district for which categorization of these areas into Category A (Affected area), Category B (Buffer area) and Category C (Clean area) has become necessary for imposition of certain restrictions and permission of limited activities;


Now, therefore, after due consultation with the Superintendent of Police, Birbhum and the Chief Medical Officer of Health, Birbhum and Rampurhat Health Districts, the areas as mentioned in Annexure of this order are hereby categorized as Containment Zone (Affected area - Category A).

It is further ordered that

1. The Block Development Officers of concerned blocks shall be responsible for all enforcement measures within their respective jurisdiction;
2. The concerned Block Development Officers, being Executive Magistrate, are hereby appointed to act as Incidence Commander for their respective jurisdiction;
3. The concerned Block Development Officers in the capacity of Incidence Commander shall form a multidisciplinary team involving Block Medical Officer of Health and his representatives, including ASHA Workers, Inspector-in-Charge / Officer-in-Charge, of Police Station, Pradhan of concerned Gram Panchayat, concerned Gram Panchayat member, Local School Teachers, Local Anganwadi Workers, SHG Members and other public representatives as deemed fit.
4. The team shall ensure intensive lockdown surveillance, contact tracing and testing in containment zones and will also ensure home delivery of essential commodities in the affected areas.


The directives and clarifications as contained in the order of the Chief Secretary to the Government of West Bengal vide Memo No. 177-CS/2020 dated 18/5/2020 will apply *mutatis mutandis* and shall be complied by all concerned strictly.

This order will take effect on and from 20/5/2020 and will remain in force until further order.
