NOTIFICATION

Whereas, it has been observed that a large number of vehicles including Small Vehicles, Goods Vehicles, Passenger Buses are being plied through Dubrajpur Illambazar Panagarh Road over Ajoy Bridge at Illambazar, and

Whereas, a proposal for repair of damaged parts of 'Ajoy Bridge' at Illambazar has been received from the Executive Engineer, Highway Division-II, P.W.D. Roads Directorate Suri, and

Whereas, movement of vehicles will create problem for urgent repairing work of Ajoy Bridge at Illambazar

Now, Therefore considering all aspects and in exercise of the power under section 115 and section 116 of Motor Vehicles Act, 1988 and Section 4(1) of West Bengal Traffic Regulation Act, 1965, I Shri P. Mohan Gandhi, IAS, District Magistrate & Collector, Birbhum do hereby ordered that

- A) The movement of all type of vehicles on Ajoy Bridge at Illambazar will be remain close on and from **3rd June,2016 to 29th June, 2016**.
- B) Small Vehicles like Motor Cycles and LMV (Car, Jeep) except Goods Vehicles to be plied on the diversion route to be developed by PWD(Roads) , BHD-II , adjacent to existing Bridge. PWD has to maintain the diversion even during monsoon and to erect "height restriction bar" on both end of diversion to avoid plying of heavy vehicles
- C) All Heavy Goods Vehicles (H.G.V.) which are moving towards Burdwan / Kolkata will divert from Md. Bazar More, Patelnagar, Sainthia, Chowhatta, Lavpur, Futisanko. All Heavy Goods Vehicles (H.G.V.) which are moving towards Durgapur / Asansole will divert from Dubrajpur to Pandabeswar Via NH 60 .
- D) All Passengers Buses which are moving towards Durgapur / Asansole from Suri / Bolpur will move up to Illambazar with shuttle trip at Birbhum side Similarly Passenger Buses which are moving from Durgapur / Asansole will move upto opposite side of Ajoy Bridge with shuttle trip at Burdwan District Side.
- E) All N.B.S.T.C. Buses which are moving towards Kolkata will divert from Suri to Kolkata, Via – Ahmedpur, Futisanko, Nutanhat.

This Notification will come into force on & from 03.06.2016 to 29.06.2016.

Note:

- (a) District Magistrate, Burdwan District is requested to inform Bhedia G.P. to maintain the approach road towards second under pass of Bhedia Bridge for smooth plying of small vehicles.
- (b) Executive Engineer Birbhum Highway Division II has to take up with Executive Engineer National Highway Division, Durgapur and Executive Engineer National Highway Division XII for repairing and maintenance of Bhedia under pass/ approach under their respective jurisdiction so that the vehicles can ply smoothly. He is further requested to give wide publicity and prepare enough flex and give to Birbhum and Burdwan police for publicity. Moreover he is requested to arrange necessary fund for the deployment of Civil Defense Volunteers (CDV) by the police for traffic regulations. Requirement of CDV for Burdwan is 10 nos. and Birbhum 40 nos. on daily basis.
- (c) BDO Illambazar is requested to fix the rate for shuttle service to cross the Ajay Bridge. He is further requested to maintain the temporary approach road at Joydeb
