**Now**, therefore considering all aspects and in exercise of power conferred upon me under sec. 115 and sec. 116 of Motor Vehicles Act. 1988 and sec. 4(1) of West Bengal Traffic Regulation Act, 1965. I, Shri P. Mohan Gandhi, IAS, District Magistrate & Collector, Birbhum do hereby order that

- a) The movement of all types of vehicular traffic will remain closed from 20.05.2018 to 23.05.2018 on Suri Township Road from Circuit House to Tilpara NH-60.
- b) The movement of vehicles from Purandarpur, Dubrajpur to Seorakuri will take diversion from Circuit House to Hospital More towards NH-60
- c) The movement of vehicles from Md. Bazar side to Suri will take diversion from Suri Power House Road(link road of NH-60 towards Sadar Hospital) to Circuit House.
