NOTIFICATION


Dated, Suri, the 08th September, 2020

Whereas, it has been learnt from Memo. No 309/Traffic Dated 07.09.2020 of The Superintendent of Police, Birbhum & Memo No. 605 Dated 06.09.2020 of The Executive Engineer, Birbhum Highway Division-I, P.W (Roads) Directorate that, a part of the Deck slab of 3m wide Canal Crossing Minor Bridge(10M length) at 21st KM on Tarapith- Birchandrapur- Hazipur- Mayureswar- Kotasur road has been collapsed and which needs immediate replacement to avoid any untoward incident.

Whereas, it is felt necessary to restrict all kind of traffic movement over the damaged Canal Crossing bridge on Tarapith- Birchandrapur- Hazipur- Mayureswar- Kotasur road at 21st KM to avoid any interruption of the said repair work and any mishap from 6.00 AM on 08.09.2020 to 6.00 AM on 08.10.2020.

Now, therefore considering all aspects and in exercise of power conferred upon me under section 115 and section 116 of Motor Vehicles Act, 1988 and section 4(1) of West Bengal Traffic Regulation Act, 1965. I, Smt. Moumita Godara, IAS, District Magistrate & Collector, Birbhum do hereby order that :

- a. No vehicle be allowed to ply over the said Canal Crossing Minor Bridge on Tarapith- Birchandrapur- Hazipur- Mayureswar- Kotasur road upto 08th October'2020 w.e.f 08th September'2020.
- b. All types of traffic movement towards Ranpurhat from Mayureswar be diverted from Canal Office Morh(under Mayureswar PS) via Bahina Morh(NH-60), Kamraghat & Hazipur(under Mollarpur PS).
- c. Traffic movement of all types of vehicles towards Mayureswar from Ranpurhat be diverted at Hazipur (under Mollarpur PS) via Kamraghat, Bahina Morh(NH-60, under Mollarpur Ps) & Canal Office Morh(under Mayureswar PS).
