
Dated, Suri, the 22nd June, 2020

Whereas, it has been learnt from Memo. No.252/Traffic Dated 22.06.2020 of The Superintendent of Police, Birbhum that one Box of the deck slab of **Gambhira Bridge**, near Nakpur Check-post at chainage KM 420.421 of NH-60 has been found severally damaged and reinforcement has fully exposed which needs immediate repair to avoid accident.

Whereas, it is felt necessary to restrict all kind of traffic movement with immediate effect on **Gambhira Bridge** to avoid any mishap.

Now, therefore considering all aspects and in exercise of power conferred upon me under section 115 and section 116 of Motor Vehicles Act. 1988 and section 4(1) of West Bengal Traffic Regulation Act, 1965. I, Smt. Moumita Godara, IAS, District Magistrate & Collector, Birbhum do hereby order that :

- a) No vehicle be allowed to ply over the Gambhira Bridge upto 06.07.2020 w.e.f 22.06.2020.
- b) Traffic heading towards Berhampore, Umarpur & North Bengal be diverted from Narkeltala Bus Stand (NH-60) to Umarpur (NH-34) via Murarai & Paikar.
- c) Traffic towards Birbhum District be diverted from Ajarpara, Umarpur and Moregram to Nalhati via Jibanti-Panchgram Under Murshidabad District.


