

## **NOTIFICATION**

## Dated, Suri, the 21st February, 2017

Whereas, it has been learnt from memo. No. 898/W-101 dated 23.10.2017 of Executive Engineer, National Highway Division No. XII, P.W.(Roads) Directorate, that the re-sectioning work of the stretch between Murarai railway level crossing and Murarai bus stand probably 280 Meter has to be executed.

Whereas, it is felt necessary to closure of Nalhati-Rajgram road from 15.00 km to 31.00 km on urgent basis.

Now, therefore considering all aspects and in exercise of power conferred upon me under sec. 115 and sec. 116 of Motor Vehicles Act. 1988 and sec. 4(1) of West Bengal Traffic Regulation Act, 1965. I, Shri P. Mohan Gandhi, IAS, District Magistrate & Collector, Birbhum do hereby order that

- a) The movement of heavy goods vehicles (Truck) will remain closed between 10:00 PM(night) to 5:00 AM(morning) from 01.11.2017 to 10.11.2017.
- b) The movement of small vehicles as well as Ambulance coming from Hahespur & Rajgram will be diverted from Murarai Natun Bazar to Nalhati via Guskira also known as Murarai bye-pass in between 10:00 PM(night) to 5:00 AM(morning) from 01.11.2017 to 10.11.2017.
