

**Whereas**, it has been learnt from memo. No. DCE/Con/ROB/SDAH/WT/562 Dated 03.07.2020 of The Deputy Chief Engineer(Con/ROB) , Eastern Railway, Sealdah & No. 271/Traffic Dated 10.07.2020 of The Superintendent of Police, Birbhum that it is urgently needed for repairing work under Railway subway portion (Rail-Fuko )on Suri-Dubrajpur Road at Rabindra Pally, Suri, Birbhum..

**Whereas**, it is felt necessary to restrict all kind of traffic movement along Rail-Fuko on Suri-Dubrajpur Bypass Road under railway subway portion on and from 12.07.2020 to 21.07.2020 to avoid any interruption of the noted repairing work.

**Now**, therefore considering all aspects and in exercise of power conferred upon me under section 115 and section 116 of Motor Vehicles Act. 1988 and section 4(1) of West Bengal Traffic Regulation Act, 1965. I, Smt. Moumita Godara, IAS, District Magistrate & Collector, Birbhum do hereby order that :

- a) Movement of all type of vehicles be restricted through Railway Subway portion (Rail - Fuko) on Suri -Dubrajpur Road on & from 12.07.2020 to 21.07.2020.
- b) All type of traffic movement towards Suri Bus Stand via Dubrajpur Bypass & Rail Fuko be diverted from Kalikandar Morh on NH-60 (under Suri PS) to Suri Bus Stand via Barabagan Bypass, Eker Pally Morh & Tibrewala Petrol Pump (under Suri PS).
- c) All type of traffic movement towards Dubrajpur via Rail Fuko & Dubrajpur Bypass be diverted from Suri Bus Stand Morh on SH-06 to Kalikandar Morh on NH-60 (under Suri PS) via Tibrewala Petrol Pump, Benimadhab Morh & Barabagan Bypass (under Suri PS).
