

Whereas, it has been learnt from memo. no. 1350/1W-178 dated 21.12.2017 of Executive Engineer, Birbhum Highway Division-I, P.W.(Roads) Directorate regarding No Parking Zone of vehicular traffic from 16.01.2018 to 15.07.2018 on the Nalhati bypass road from CADC More to BDO office more for a period of 6 months as there was a need for widening & strengthening work of existing two lane carriage way of Nalhati Bye pass Road from 0 to 3.00 km and Connstruction of ROB on Nalhati Bye Pass road is to be completed by Feb-2019 under Birbhum Highway Division-I in the District of Birbhum.

Whereas, it has been felt necessary to execute this work uninterruptedly and quickly.

Now, therefore in exercise of power conferred upon me under sec 115 and 116 of Motor Vehicles Act, 1988 and 4(i) of West Bengal Traffic Regulation Act, 1955, I Shri P. Mohan Gandhi, IAS, District Magistrate & Collector, Birbhum do hereby order that

- a) The entire road stretch alongwith shoulder portion from CADC more to BDO office more on the Nalhati bypass in Nalhati P.S. has been declared as "No Parking Zone" for all heavy vehicles from 16.01.2018 till further order. Violation if any to be dealt as per the law in force. Nalhati P.S. and Executive Engineer, Birbhum Highway Division-I are requested to give wide publicity.
