NOTIFICATION

It is learnt from the Memo No : 901/WB (Gambhira) Dated- 20.12.2016 of Executive Engineer , National Highway Division No XII PW (Roads) Directorate , Suri, Birbhum that Gambhira bridge located at Chainage Km. 420.21 on NH 60 has been damaged, so it has become expedient to impose total prohibition of flow of vehicular traffic over the bridge and the traffic diversion is necessary for the convenience of public for a temporary period to facilitate repair work of the bridge.

So, in exercise of power conferred upon me under Sec.115 and 116 of MV Act. 1988 and Sec 4(1) of WB traffic regulation act 1965, I P Mohangandhi IAS, District Magistrate, Birbhum do hereby ordered that a vehicular traffic is prohibited from 24th December, 2016 to 7th January 2017 over the said bridge and the traffic is diverted in the following manner:-

- 1) Malda bound traffic to take diversion route from Nalhati to Umarpur via Murarai, which meets NH34 at Umarpur.
- 2) Berhampore bound traffic to take diversion from Nakpur check post to Palsanda where the route meets NH 34 at Palsanda via Panchgram and Naogram.

Necessary traffic sign will remain erected at the point of diversions.

The notice is issued in the interest and convenience of public.
