Now, therefore considering all aspects and in exercise of power conferred upon me under sec. 115 and sec. 116 of Motor Vehicles Act. 1988 and sec. 4(1) of West Bengal Traffic Regulation Act, 1965. I, Smt. Moumita Godhara Basu, IAS, District Magistrate & Collector, Birbhum do hereby order that

- a) The movement of all types buses and trucks (HGV & MGV) will ply from Suri Town towards Bolpur/Labpur/Ahmedpur/Kirnahar/Sainthia via Rabindrapally railway under pass through Hatzanbazar Bypass following one way traffic.
- b) Buses/Trucks (HGV & MGV) coming from Bolpur/Ahmedpur/Kirnahar/Sainthia will enter Suri Town directly through existing Suri - Bolpur Road via Hatzanbazar Rail gate following one way traffic.
- c) All small vehicles from Suri Town to Bolpur/Ahmedpur/Kirnahar/Sainthia and also in the reverse direction will play through existing Suri - Bolpur road via Hatzanbazar Railgate following both way traffic.
