NOTIFICATION

Dated, Suri, the 14th Oct'2020

Whereas, it has been learnt from the Memo. No. 9423/DIB Dated 14.10.2020 of The Superintendent of Police, Birbhum & Memo No. 901/W-115 Dated 14.10.2020 of The Executive Engineer, National Highway Division-XII, P.W (Roads) Directorate that, suddenly a hole has been found in the Deck slab of the **Dwarka Bridge** located near Deocha at chainage KM 359.751 of NH-60, which needs immediate repair to avoid any untoward incident.

Whereas, it is felt necessary to restrict traffic movement of all kind of vehicles over the damaged Dwarka Bridge at chainage at KM 359.751 of NH-60 to avoid any interruption of the said repair work of said developed hole and any mishap from 6.00PM of 14.10.2020 to 10.00 Am of 15.10.2020.


Now, therefore considering all aspects and in exercise of power conferred upon me under section 115 and section 116 of Motor Vehicles Act. 1988 and section 4(1) of West Bengal Traffic Regulation Act, 1965. I, Smt. Moumita Godara, IAS, District Magistrate & Collector, Birbhum do hereby order that:


- a) Movement of all type of vehicles be restricted over damaged Dwarka Bridge from 6.00Pm of 14.10.2020 to 10.00AM of 15.10.2020.
- b) Traffic towards Rampurhat be diverted from Md. Bazar (KM352.680) of NH-60 to Sainthia & further diveted from Taltala More, Sainthia to meet NH-60 at Mallarpur (KM374.000) of NH-60.
- c) Traffic towards Suri be diverted from Mallarpur (KM374.000) of NH-60 to Sainthia & further diverted from Nutan Bridge More to meet NH-60 at Md. Bazar (KM352.680) of NH-60.
- d) Traffic towards Suri (Bardhaman bound goods vehicles) from Nalhati be diverted from Nakpur Checkpost (under Nalhati PS) towards Panchgram (PS: Nabagram, Dist: Murshidabad).
- e) All Rampurhat bound Trailors/Semi-Trucks/Large Container vehicles be diverted from Seorakuri Morh under Md. Bazar PS, towards Jharkhand via Chhagalkuri Check-post.
