**NOTIFICATION**

**Dated, Suri, the 31<sup>st</sup> January, 2020**

**Whereas**, it has been learnt from memo. No.89/Ajoy Bridge dated 27.01.2020 of Executive Engineer, Birbhum Highway Division-II, P.W.(Roads) Directorate, that the bridge over river Ajoy at Illambazar Road has been badly damages.

**Whereas**, it is felt necessary to repair the above mentioned bridge on urgent basis and requires partial closure of the bridge that is one way movement at one time for the work can be executed at the half portion of the bridge.

**Now**, therefore considering all aspects and in exercise of power conferred upon me under sec. 115 and sec. 116 of Motor Vehicles Act. 1988 and sec. 4(1) of West Bengal Traffic Regulation Act, 1965. I, Smt. Moumita Godara, IAS, District Magistrate & Collector, Birbhum do hereby order that

- a) The movement of heavy goods vehicles will remain closed from Illambazar triangular park towards Ajoy river bridge from 02.02.2020 to 17.02.2020
- b) The goods vehicles movement towards ADPC, Bankura, Howrah, Medinipur be diverted from Joydeb Morh on SH-14(under Dubrajpur PS) to Muchipara Morh on NH-02 via Bishnupur & Malandighi (under Kanska PS) and from Satkenduri Morh on NH-60 (under Dubrajpur PS) to Panjabi Morh on NH-02 (under Raniganj PS) via Pandabeswar & Haripur (under Pandabeswar PS).
- c) The movement of all type of passenger Bus and small vehicles(LGV) be as usual during the period of closure.


