**NOTIFICATION**

**Dated, Suri, the 11<sup>th</sup> July, 2019**

**Whereas**, it has been learnt from Memo. No. 934/S dated 08.07.2019 regarding closure of road for heavy vehicles and full restriction of traffic movement by deputing traffic personnel from 12.07.2019 at the location of Hatzanbazar for execute the piling work and other foundation structure at Bolpur end approach in pier mkd P13, P14, P15, P16 and A2 will be started from 13.07.2019 up to 30.09.2019  
**Now**, therefore considering all aspects and in exercise of power conferred upon me under sec.115 and sec.116 of Motor Vehicles Act. 1988 and sec.4(1) of West Bengal Traffic Regulation Act, 1965. I, Smt. Moumita Godara Basu, IAS, District Magistrate & Collector, Birbhum do hereby order that,

- a) Bolpur/ Labpur/ Ahmedpur/ Kirnahar/ Sainthia via Rabindrapally bound all type of Buses and Trucks (HGV & MGV) will move up to Suri Bus Stand and will back.
- b) From Bolpur/Labpur/ Ahmedpur/ Kirnahar/ Sainthia side all type of Buses and Trucks (HGV & MGV) will move up to Jamal Khosnatore canal Par and will back.
- c) For the Piling and construction work the vehicles as mentioned in point "a & b" will not cross Hatzan Bazar Rail Gate under any circumstances as per above mentioned period.
- d) All small vehicles, Two Wheelers, Ambulances & small vehicles in emergency cases from Suri Town to Bolpur/Ahmedpur/Kirnahar/Sainthia and also in the reverse direction will ply through existing Suri - Bolpur road, via Hatzanbazar Railgate following in both way traffic.
- e) All type of vehicles are allowed to move freely from Station More (towards Bolpur) may avail first left turn. Then may move Kendua to Kulera more via Rakkha Kalitala, Bolpur Suri Road and all vehicles can move without crossing or touching Suri rail gate level crossing at Hatzanbazar.
