

No.345 dated 26.05.2020 of The Executive Engineer, Birbhum Highway Division-I, P.W.(Roads)Directorate., that two(2) nos. of double celled Box Culverts in replacement of damaged culverts on Purandarpur- Rongaipur Road, one at Dhaltikuri which is 3.90KM from Purandarpur & other at Bansra, which is 6.14KM from Purandarpur is under construction.

- b) Movement of all type of loaded vehicles (Stone materials & Sand mainly) will be diverted through Mollarpur- Majhipara-Bolpur Road or National Highway-60 from 26.05.2020 to 25.06.2020.


