In connection with memo. no. 369/C dated 07.05.2019 issued by the Superintendent of Police, Birbhum it has been learnt that the loaded heavy goods vehicles movement are to be restricted at Bolpur-Suri Road specially at Purandarpur area.

Now, therefore in exercise of power conferred upon me under sec 115 and 116 of Motor Vehicles Act, 1988 and 4(i) of West Bengal Traffic Regulation Act, 1955, I Smt. Moumita Godara, IAS, District Magistrate & Collector, Birbhum do hereby further order in cancellation of previous Notification No. 450(16)/MV dated 07.05.2019 that

- a) The movement of all types of loaded Trucks and Dumpers(except Govt. Vehicles, Ambulance, Emergency Services, Food Grains carrying vehicles & those vehicles carrying Essential Commodities) will remain closed at the following routes which are passing through Purandarpur from 06:00 AM to 08:00 PM with effect from 07.05.2019 until further order –
