NOIFICATION

Whereas, it has been observed that a large number of vehicles including Small Vehicles, Goods Vehicles, Passenger Buses are being plied through Lalpul (ROB No. 71) at Bolpur and,


Whereas, a proposal of construction of new ROB in lieu of ROB No. 71 has been received from the AEN/CON/BWN AT HWH, Eastern Railway, Howrah and,

Whereas, Road Traffic over existing ROB will be diverted for construction of new bridge in same place at ROB 71.

Now, Therefore considering all aspects and in exercise of the power under section 115 and section 116 of Motor Vehicles Act, 1988 and Section 4(1) of West Bengal Traffic Regulation Act, 1965, I Shri P. Mohangandhi, IAS, District Magistrate & Collector, Birbhum do hereby ordered that

- A) The movement of all type of vehicles through Lalpul (ROB No. 71) at Bolpur will remain close on and from 15/05/2015.
- B) All Passengers Buses which are plying Bolpur - Labpur-Nanoor will run via Prantick Township _ Shyambati-Santiniketrn -Tourist Lodge more. .
- C) All Passengers Buses which are plying from Palitpur -Bolpur will run via Nimtala- Durgapur- Gheropara- Supur -Kashipur-Bypass.
- D) Goods Vehicle in the eastern side of Railway track to and from Bolpur - Sainthia, Suri- Illambazar will run via Makrampur - Prantik - Ahamedpur.
- E) Goods Vehicle in the eastern side of Railway track to and from Bolpur - Burdwan, Illambazar will run via Bolpur - Nimtala- Durgapur - Gheropara - Aban Setu.

This Notification will come into force on & from 15.05.2015 till completion of the work. This is issued to continue normal public Transport system of that area subject to approval in next RTA Board meeting.
