
The eligibility criteria are given below: -

- Income Tax return should be uploaded for the last 3 (three) financial year with the Technical Bid.
- Copy of Professional Tax clearance certificate, GSTIN registration certificate & PAN Card & last I.T clearance should be uploaded.
- All duties, taxes, royalties, cess, toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates prices and total Bid price submitted by the bidder.
- In case of Electrical works the agency should have personnel having **Electrical Contractors license & Supervisory license** of respective category (1,2,7A, 10 & 11)
