

- Date of Opening Sealed Quotation: 28/11/2019 at 3.00 P.M
- o Place of Opening Sealed Quotation: In the meeting Hall in presence of Tender Committee.

#### Terms & Conditions:

- 1. The selected consultant shall have to execute an agreement with this Authority on non-judicial stamp paper before issuing the work order.
- 2. The Authority reserves the right to accept or reject any quotation without assigning any reason thereof.
- The consultant is liable to rectify the DPR as may be pointed out by the Vetting Wing of concerned Department. No extra claim for this purpose will be entertained by the Authority.
- 4. The payment will be made after according Technical Vetting from appropriate Authority by deducting 50% from Final Bill amount. The balance amount will be paid proportionately after submission of working drawings as per requirement.
- 5. If the consultant fails to submit the DPR in time, the Authority may terminate the same consultant by giving a seven days notice.
- 6. The consultant shall have to prepare the DPRs under strict compliance of Engineer in charge of this Authority.
