





Time is the essence of contract. The successful Tenderer must complete the work within the time specified for completion. **No extension of time will be allowed except in special case. If any Agency fails to complete the work within stipulated time, the Work order /Supply order issued in his favour will be cancelled without assigning any reason thereof.** The undersigned may also proceed to get the balance work completed by any other means including through other Agency. The excess expenditure, if any, due to such a step would be recoverable from the unpaid bills/Earnest money deposite /security deposit of the Tenderer. **As per rule; Clause (2) will be applied to the defaulting Agency.**

- The authority shall straightway reject the price-bids which may appear to be absurd in terms of rates and with the mala-fide intention of competition only. Withholding the offer of price en-masse shall be construed as a deliberate action as to jeopardizing the speedy execution of the scheme and such bidders shall be black-listed for the future course of Tenders of undersigned.


