

- EMD:- An earnest money of Rs. 5,000/- (Five Thousand) only for participation in tender is to be deposited by the bidder in the way as DD/Bankers Cheque in favour of 'Rampurhat S.D. Hospital, RKS payable at Rampurhat'.
- 3.
