

Intending tenderers may download the tender documents from the website <http://wbtenders.gov.in> directly with the help of Digital Signature Certificate and earnest money should be deposited through online only as per the option available in <http://wbtenders.gov.in>.
2. The bidders information sheet in excel format must be filled up properly.
3. Bid validity period is 90 days from the date of opening of the technical bid.
4. Trade license, GST Registration Certificate, Income Tax return, latest GST return, Pan Card, Professional tax deposited challan along with enrollment certificate should be uploaded in Part-I technical bid.
5. Necessary deduction will be made as per Govt. Norms.
