



Notice inviting expression of interest (EOI) for Printing Ballot Papers for the ensuing 9<sup>th</sup> Panchayat General Election, 2018 in Suri Sadar Sub-Division, Birbhum.

In view of the ensuing 9<sup>th</sup> Panchayat General Election, 2018 for the three tier Panchayat System in Suri Sadar Sub-Division, it is required to prepare a huge amount of Ballot Papers for the said Election in different Blocks in Suri(Sadar) Sub-Divisional jurisdiction. For that, it is necessary to identify a number of Printing Presses within the Suri Sadar Sub-Division with the following required facilities :

1. Offset Printing Process.
2. Power backup.
3. Sufficient space for checking and splitting work, sitting of Staff and Police.
4. Facility for cutting machine.
5. Facility for numbering and stitching .
6. Sanitation facility.
7. Wide approach road for the movement of official vehicles and fire fighting vehicles in case of emergency.
8. Willingness to undertake continues printing of ballot papers and not to undertake printing of any dummy Ballot Papers for personal use of Candidates and Political parties.
9. Willingness to setup temporary structure for use of official Staff and for strengthening security aspects.

The owner of the press within the Suri Sadar Sub-Division , Birbhum having the above mentioned facilities are requested to submit their expression of interest for Printing Ballot Papers to the office of the undersigned within **4.00 pm on 03/04/2018** with a hand sketch map of the precise location of the press. They are also required to mention if they had any previous experience in this nature of job. They should submit their EOI along with necessary documents/declaration in satisfaction of the above 9(nine) points.
