- iii) The goats to be supplied must be maintained properly to maintain quality. The supply must comport to the given specification in Quotation. In case, any animal will die, replacement by fresh animal would be done within next 10 days.
- iv) Supply must be commenced within specified timeframe from the date of placement of formal order or the date as indicated in the order.
- v) Supply will normally be accepted on all working days between 11 am & 3 pm. Successful Tenderer must provide requisite number of labor for loading / unloading of the goats without any additional charges. No supply will be accepted on Sundays & Govt. Holidays unless otherwise desired by the receiving authority.
