3. GST annual return in GST enabled Tally. ERP9.

TERMS AND CONDITIONS

1. The consolidated rate for the above assignment should be quoted both in figure and words with breakup of all taxes as applicable in West Bengal, on yearly basis. The details of taxes may also be depicted. The quoted rate should be inclusive of all incidental charges, i.e. travelling allowance, tiffin allowance, etc.
2. Quotation in marked and sealed cover along with attested copies of valid Trade License, PAN Card, GST No. and credentials should be dropped in the earmarked box kept in the office premises up-to 1:00 PM of 24-12-2020 specifying clearly on the top of the envelope "QUOTATION FOR PREPARATION OF MONTHLY ACCOUNTS IN GST ENABLED TALLY.ERP9." The quotations will be opened on the same day, i.e., 24-12-2020 at 1:30 PM and interested quotationers are requested to remain present at the time of opening the quotations.
3. The office reserves the right to accept or reject all the quotations without assigning any reason thereof.
4. Payment will be made through A/c payee cheque against submission of bills in duplicate on pro-rata basis.
5. The penalty, if any imposed by GST authority due to wrong/delayed filling or for negligence of the agency, will have to be borne by the said agency. In such case the agency shall be liable to compensate any loss suffered by the corporation.
6. The contract will be initially for one year starting from the date of execution of the agreement. If the service of the agency is found satisfactory, the contract with the agency may be extended on year to year basis upon mutual agreement between the parties. However if any discrepancies are noticed during the contract period, the contract can be terminated by giving one month's notice.
